

## Financial support regarding child care contributions

You can get different kinds of financial support:

The information is non-binding, non-final and serves as information and help for you.

### a) Contribution reduction or exemption from the youth welfare office, economic youth welfare

Upon application, the youth welfare office can either take over the contributions in whole or in part if the financial burden is too unreasonable for you.

A takeover or subsidiary depends on the amount of your income.

The support is possible for all types of child care, i.e. nursery, kindergarten and school child care.

Please note: additional contributions like lunch or such are not covered by the youth welfare office.
